

# WOODSTOCK POLICE SERVICES BOARD

The Woodstock Police Services Board met on May 10, 2021 at Woodstock Police Service headquarters and via ZOOM at 3:00 p.m.

Present were: Ken Whiteford, Provincial Appointee; Mayor Trevor Birtch, Provincial Appointee; Balwant Rai, Community Member; Leslie Farrell, Provincial Appointee; Deb Tait, City Councilor and Amy Hartley, WPSB EA.

Also in attendance were Chief Daryl Longworth, Deputy Chief Rod Wilkinson, Kristi Lampman, Human Resources Coordinator, Kathleen Saylors, Woodstock Sentinel Review, Marci Shelton, Inspector (attended at 3:15 pm), Kevin Talsma, Acting Inspector.

### 1. CALL TO ORDER

Ken WHITEFORD called the meeting to order at 3:00 p.m.

### 2. WELCOME

Ken WHITEFORD welcomed everyone.

### 3. APPROVAL OF AGENDA

### 7. VERBAL REPORT FROM CHAIR

- The Chair noted that Police Week is May 9<sup>th</sup>-15<sup>th</sup>, 2021. The theme for the week is "working together to keep our communities safe".
- He noted that this is an annual recognition and focuses on community awareness, while strengthening the relationship between the police and those they serve.
- Police Week coincides with Peace Officers Memorial day on May 15, 2021.

## 8. VERBAL REPORT FROM CHIEF

- The Chief noted that because of COVID regular activities that are usually held during Police Week cannot occur.
- The Chief advised that the WPS are trying to show recognition through social media with agencies. An event called "Coffee with a Cop" is going to be held with Inspector Shelton and Officer D'Annibale to answer questions from the public.
- Typically for Peace Officers Memorial Day a contingent is sent to Toronto to participate in a march, however, due to changes this year a video has been put together for the website showing recognition of day.
- There have been a number of high profile incidents, including robberies involving weapons, and hit and run investigations. These investigations and incidents require more hours from the WPS to make the arrest.
- There has been a disturbing increase in overdose calls. WPS is attempting a different approach to these types of calls wherein, the individuals are sent to the situation table to try and get them follow up care after the incident. Some calls resulted in a deceased individual where naloxone was issued, but ineffective.
- The Chief noted that suicide calls are up over 100 calls since last year.
- The Chief recognized that there is a struggle with the homeless population which generates a lot of work for WPS. A number of different intervention strategies have been attempted, however they have not been effective. WPS is trying to get some type of court ordered treatment for those

individuals. The Chief recognized that this is a complex problem that is difficult to solve. The Community Response Unit is working to get involved in some type of intervention and mental health services. WPS continues to meet with agencies to receive input on solutions.

- Training has been occurring with adapted methods. A session occurred wherein 14 members participated in search and rescue training.
- WPS hosted a wellness- challenge for the month of May which encouraged increased physical activity
- There have been nearly 200 calls in relation to COVID-19. The calls were mostly dealing with gathering limits. Public health have notified that WPS had dealt with people and they ended up testing positive, this requires investigation into those WPS members that could have been in contact with those individuals. Due to increased health and safety measures the impact has been low. Some members have been required to stay home.
